**Subject: Policy regarding provision mobile handsets for GSM mobile service connection in BSNL to JAG and above level officers.**



In partial modification of this office circular nos. referred above issued from this office , the following decision have been taken with regard to provision of handsets for GSM mobile service connection in BSNL :-

1. Competent Authority has approved to discontinue the existing system of providing Blackberry handsets to JAG and above level officers and revert to old system of providing reimbursement of cost of the GSM mobile handsets to JAG and above level officers once in three years at the following revised rates :-

S.No.	Level of officers	Financial Limit In Rs.
1.	CMD and Functional Director	Need Basis
2.	ED Level Officers	20,000/-
3.	HAG and SAG Level Officers	15,000/-
4.	JAG Level Officers	8,000/-

2. The responsibility of the repair, replacement warranty guarantee, theft, lost quality, and features etc. lies with the users.
3. The instructions issued vide circulars referred above shall stand modified to the extent mentioned herein above. Other terms and conditions governing policy regarding provision of handset for GSM mobile service connections issued vide this office circulars referred at 1 and 2 above shall remain unchanged.
4. These instructions shall be effective from the date of issue of this circular.
