Subject: Revision of fixation of Norms for providing funds for maintenance & operation of Electro-Mechanical services in Telecom buildings.

Guidelines on the above subject and adhoc norms for providing funds for mtce. of Electro-mechanical services in Telecom. Bldgs. were circulated vide DOT letter No. DDG(Elect.)/Guide/98 dated 2/4/1998 and letter No. 5-1-42/EW-99 dated 14/2/2000.

The proposal for the fixation of the norms for preparation of the estimate for maintenance and operation of Electro-Mechanical services was under consideration in BSNL C.O.

Consequent upon approval of competent authority, the revised norms has now been fixed as under :-

A. Maintenance Cost

B. Operation Cost:-
