ORDER

2. The above posting on LAA arangment in higher grade will not count for any benefit in matters of future promotion, seniority etc. and will not confer any right on them to continue in the post/station/grade.


3. This looking after arrangement shall be on a stand-alone basis and shall not exceed 180 days at a time w.e.f. the date they assume charge of their respective posts. The executives shall stand reverted to their substantive grade of JTO(C) automatically on completion of 180 days or until further orders whichever is earlier.

4. The above executives shall exercise only functional powers i.e., Administrative and Financial powers attached with the post and shall not exercise statutory powers.

5. In case any vigilance / disciplinary case is pending against any of the above officer(s), or if any penalty imposed on them is current, he should not be relieved to take-up his new assignment and facts should be intimated to this office immediately.


6. The date on which the order is given effect may be intimated and charge assumption report furnished to all concerned.
