ORDER

Sub: Looking After Arrangements (LAA) in the grade of SDE(C) – reg.

In terms of powers conferred vide BSNL CO order No. 412-13/2013-Pers.I(II) dated 22.03.2013 & order No. 412-13/2011-Pers-I dated 29.04.2013 the following JTOs(C) are hereby ordered to look after the current duties of the post of SDE(C), with immediate effect or the date on which the officer assumes charge whichever is later as detailed below:

2. The above posting on LAA arrangement in higher grade will not count for any benefit in matters of future promotion, seniority etc. and will not confer any right on them to continue in the post/station/grade.

3. This looking after arrangement shall be on a stand-alone basis and shall not exceed 180 days at a time w.e.f. the date they assume charge of their respective posts. The executives shall stand reverted to their substantive grade of JTO(C) automatically on completion of 180 days or until further orders whichever is earlier.


4. The above executives shall exercise only functional powers i.e., Administrative and Financial powers attached with the post and shall not exercise statutory powers.
