Sub: Regular promotion from JTO(C)to SDE(C) under Seniority Cum Fitness quota-Reg

Respected Sir,

With reference to the above subject matter we would like to draw your kind attention towards the stagnation in the cadre of JTO (Civil). Stagnation level in this cadre is very alarming, as the JTO(C) of 1989 batch are still waiting for their first functional promotion even after completion of more than 23 years of regular service.

The above few lines speak itself the plight and pathetic situation of JTOs(C) in which they are working. The BW unit of BSNL, instead of taking necessary action to reduce the stagnation period (By filling all the vacant post of SDE[©]/ Restructuring the cadre of JTO[©]), is playing game with frustrated and demoralized cadre of JTO[©]. The following few facts and figures are self explanatory to highlight the lackluster attitude of BW management toward the cadre of JTO[©].

- 1. BW unit has called the ACR of 98 JTOs (i/c 12 already promoted/VRS/Expired JTOs) for the regular promotion to the cadre of SDE[©] vide letter No. 2-2/2011/Dy.M(BW-II) dated 06.04.2011 (copy enclosed).
- 2. Further BW unit has called the ACR of only 50 JTOs (out of previously called ACR of 98 JTOs) vide letter No. 2-2/2011/Dy.M(BW-II) dated 13.12.2011 (copy enclosed).
- 3. BW unit has issued Post based Roster in SDE[©] cadre vide letter No. Roster/SDE[©]/M(BW-II) dated 27.02.2012 (copy enclosed), which shows the Cadre Strength 653 and working strength 593 in Seniority Cum Fitness quota as on 01.01.2012, But the actual working strength was 563 (As 30 Nos official was already Expired/Retired/VRS, promoted as EE or working as JTO as on 01.01.12 details are enclosed as per Annexure A).
- 4. After continuous pursuance of Association BW unit called the ACR of another 82 JTOs vide letter No. 2-2/2011/Dy.M(BW-II) dated 20.03.2012 (copy enclosed).
- 5. 6 more vacancies has arises upto 01.05.2012 under SCF quota due to retirement/VRS of SDE[©].

Hence, you are kindly requested to direct the BW management to call the VC of remaining 82 JTOs whose ACRs has already called vide letter No. 2-2/2011/Dy.M(BW-II) dated 20.03.2012.
