Rotational transfers - 2014 in the grade of SDEs(C) - calling for options -Sub: regarding.

It is proposed to carry out rotational transfers for the current year 2014 in the cadre of SDEs(C). In this regard, it has been decided to call for options regarding choice of stations from the executives.

- Hence, it is requested that two options regarding choice stations of posting may be called from:-
 - Field executives who shall be completing four years of field tenure as on 31.03.2014; and
 - Executives in planning offices who shall be completing two years of ii) planning tenure as on 31.03.2014

working under your control and forwarded to this office on or before 10 - 03 - 2014.

- 3. The SDEs (C) who are currently in planning posts and shall be completing their respective planning tenures but not desirous for field posting may specifically indicate their unwillingness to move to field units.
- However, it may be made clear to the optees that transfer to their choice stations would be subject to the availability of vacancies and administrative requirements and hence exercise of option shall not confer upon them any right to claim posting in a particular station / post.
- It may be brought to the notice of SDE(C)s that due to austerity measures, preference shall be given to those optees who are ready to forego their TA/DA on transfer. Hence optees shall specifically mention their willingness to forego TA/DA on transfer in their representations.
